Project Manager

- (i) Graduate in Civil Engineering.
And
- (ii) Appropriate post qualification experience (minimum 10 years) in relevant field and atleast 5 years experience in Building, Bridge and Road Construction Work.
- (iii) Has served in Govt./Semi Govt./Public Sector/ Reputed Ltd. Company.
And
- (iv) Has served atleast 3 years in the relevant post and grade immediately one level below post applied for.
OR (Only for Deputation)
Has served atleast 6 years in a relevant post and grade, immediately two levels below the post applied for.
OR
Has served atleast 6 years cumulatively in two relevant consecutive posts, including the post and grade immediately one level below the post applied for.

The above amended rule shall also apply to the employees serving in the USIDCL on deputation.

GENERAL INFORMATION

- Maximum age for various posts will be as under:-
 - (i) **On deputation:-** Must have minimum 3 years residual service on the date for receiving application i.e. 24.04.2017.
 - (ii) **On Regular:-** Maximum age limit as on 01.01.2017 for the above posts will be 42 years.
 - (iii) Relaxation in terms of upper age limit is admissible to SC/OBC candidates as per the policy of the Uttarakhand Government and for Ex. Serviceman as per GOI rules.
- For regular posts, the applicant will have to appear written test subsequent to interview.
- Only one application from a candidate will be entertained for the advertised posts, candidates applying for more than one post shall be disqualified. Reserved vacancies will be available for candidates having their caste certificates issued from Uttarakhand State only.
- Vertical and Horizontal reservation for the above advertised posts will be applicable as per the policies of the Government of Uttarakhand.
- USIDCL will not be responsible for application lost in transit. No correspondence in such cases will be entertained.
- Only short listed candidates will be invited for interview. No correspondence or enquiry (written or personal) will be entertained in this regard.
- The number of posts may increase or decrease.
- The above advertised posts have all India liability.
- Application found incomplete in any respect shall be summarily rejected.
- Any lobbying/canvassing would disqualify the candidate.
- Initially the deputation period is for three years but can be reduced or extended as per requirement of the Corporation.

- Experience of working in IT enabled/Computer environment is desirable for all the above posts. Candidates possessing higher qualification will be given preference.
- Candidates serving Government/Quasi Government Department/Organization/ Undertaking will be required to submit their application through proper channel along with:-
 - i) No Objection Certificate from the parent department of the candidate.
 - ii) Certificate to the effect that no adverse entry exists in last five years' ACRs of the candidate.
- It is required to submit the self attested copies of Educational qualification, Experience Certificate, NOC and any other documents which required to submit for the post applied for.
- An advance copy of application can be submitted to avoid delay in submission of application through proper channel.
- Allowances and pay protection to candidates on deputation shall be given as per present rules/regulations of the State Government.
- Other perks will be admissible as per USIDCL rules.
- For above posts, send your application accompanied with non-refundable Bank Draft of Rs 600/- for General category post. Candidates who applied earlier may submit the difference amount of fee through Demand Draft.
- The Bank draft should be drawn in favour of MD, USIDCL payable at Dehradun.
- Post qualification experience will only be considered till last date of receipt of application i.e. 24.04.2017.
