Applications are invited from the Contractors of Bridge, Building, Pavement and Electrical works for Empanelment in BRIDCUL. Interested Contractors can apply as per the prescribed application form which can be downloaded from BRIDCUL website www.bridcul.com under the title “Empanelment” and submit to the Managing Director, BRIDCUL. The Contractors already empanelled with Corporation and wish to upgrade their class and category as per new eligibility criteria may also apply for up-gradation. Contractors applying afresh as well as already empanelled with this corporation are required to submit their PF subscription, ESI Registration certificate as per current requirement of terms & conditions for empanelment of Contractors- (2017-18), if not submitted earlier.

Changes, if any, will be intimated only through our website.

Appendix - A

Detailed Terms & Conditions for empanelment of contractors will be as follows:-

1. Title

(i) These terms and conditions shall be called the “BRIDCUL detailed terms & conditions for empanelment of contractors- 2017-18”

(ii) These terms and conditions shall come into effect from the date of issuance.

2. Short Title

Hereinafter these terms and conditions shall be referred to as “Detailed Terms & Conditions for Empanelment of Contractors- 2017-18” for the sake of brevity.

3. Applicability

Sole Proprietorship Firm, Partnership Firm, Public Limited Company or a Private Limited Company is entitled to get empanelled as a contractor in BRIDCUL under these Rules provided the eligibility criteria and other conditions are satisfied. The empanelled contractors have to abide by all the terms & conditions made herein and as amended from time to time during the prevalence of their empanelment.

3.1 No individual, or a firm having such individual as one of the partners, who is a dismissed government servant; or removed from the approved list of contractors; or demoted to lower class; or having business banned/ suspended by any government department in the past; or convicted by a court of law shall be entitled for empanelment.

3.2 No Engineer or any other official employed in Engineering or Administrative duties in the Engineering Department of the Government of India is allowed to work in the BRIDCUL either as contractor or as employee of a contractor for a period of two years after his retirement from Government service unless he has obtained prior permission of Government of India to do so. Even after empanelment, if either the contractor or any of his employees is found to be a person who had not obtained the prior permission of Government of India as aforesaid, the name of the contractor shall be removed from the list of empanelled contractors.

3.3 A contractor is permitted to have empanelment in more than one category but not in more than one class of the same category in BRIDCUL.

3.4 A contractor is not permitted to have empanelment in more than one name.

3.5 A partner of a firm or a director of a company empanelled as a contractor cannot be a partner/director in any other empanelled firm/company.

4. Scope

The empanelment of a contractor in BRIDCUL shall only entitle him to be considered for issue of tender papers subject to the eligibility conditions laid down in each individual Notice Inviting Tenders (NIT). It shall not confer any right on him either to be necessarily issued the tender papers or for award of work. Mere empanelment will not guarantee awarding of any work.

5. Empanelment Procedure

5.1 The contractor shall have to submit the application in a prescribed form (Annexure-1) to the empanelment authority, complete with all documents as per Annexure II.

5.2 Incomplete applications and applications not accompanied with necessary documents are liable to be rejected.

- 5.3 The empanelment authority shall have the right to independently verify the details furnished by the contractor and to get work done by the contractor inspected and/or to get such other reports as may be considered necessary. Contractor may be asked for be present in the office of empanelment authority before his empanelment.
- 5.4 If the empanelment authority finds the contractor suitable for empanelment it shall issue the empanelment order and, otherwise, send a letter of rejection of the application to the contractor. The decision of the Managing Director, BRIDCUL shall be final and binding on the contractor.
- 5.5 The empanelment authority reserves right to limit number of contractors to be empanelled in any class or category on All India/Regional/State/Location basis or any other manner decided by it.

6. Period of empanelment

The empanelment shall be valid for a maximum period of three years or upto 31.06.2020, whichever is less . The empanelment can, however, be revalidated in accordance with rules in this regard.

7. Categories and Classes

The empanelment shall be done in following categories:

- A) **Buildings** (Residential building, Institutional Building, Educational Building, Rail/Airport/ Bus Terminal, Commercial Complex)
- B) **Bridges** (Flyover, Rail –over- bridge, Viaduct, Skywalk, Ropeway etc.).
- C) **Pavements** (Road, Highway, Expressway, Runway, Helipad).
- E) **Electrical services** (External and Internal Electrification.)

The classes and categories are mentioned in **Tables-1**.

8. Tendering Limits

The jurisdiction in which contractors empanelled in various categories and classes shall be permitted to tender and the tendering limit up to which they shall be eligible to tender are as given in Table-1. The contractor shall be governed by the provisions existing at a particular point of time irrespective of when he was empanelled.

9. Authority for Empanelment

Empanelment in different categories and classes shall be done by BRIDCUL. Managing Director, BRIDCUL reserves the right to accept or reject an application without assigning any reason.

10. Eligibility Criteria

The contractors shall have to satisfy the minimum eligibility criteria specified in Table-1, before they can be considered for empanelment. All contractors are expected to keep abreast with empanelment modified from time to time

- 10.1 The criterion for experience, in case of empanelment, shall be the completion of requisite number of works, as the case may be, of prescribed nature and magnitude executed on independent contract basis or as a builder, during the last five years. The works should have been executed in the same name and style in which the empanelment is sought.
- 10.2 The financial soundness shall be judged on the basis of the solvency certificate issued by the Bankers of the contractor on the format prescribed in Annexure-V. Such certificate shall be issued by a scheduled bank and shall be submitted in original.
- 10.3 The criteria for empanelment shall be as applicable on date of empanelment. The application may be decided within 90 days of submission of applications.
- 10.4 In order to be eligible for a future work, the Cumulative Annual Turnover of an empanelled contractor in the last three years shall not be less than the estimated cost of the work. The empanelled contractors of the same class and category shall be asked to furnish their Annual Turnover of last three years alongwith their tenders.

11. a) Empanelment Fee

The contractor shall have to pay a non-refundable empanelment fee by crossed Demand Draft of any nationalized / scheduled bank drawn in favour of BRIDCUL payable at Dehradun, Uttarakhand. For various categories and classes of empanelment, the fee is prescribed in Table-1. This fee is to be submitted along with application form to the empanelling authority.

b) Security Deposit

The contractor shall have to pay a refundable security deposit by crossed Demand Draft of any nationalized / scheduled bank drawn in favour of BRIDCUL payable at Dehradun, Uttarakhand. For various categories and classes of empanelment, the fee is prescribed in Table-1. The security deposit can be used as standing earnest money on the request of contractor at the time of tendering. This fee is to be submitted along with application form to the empanelling authority.

12. Electrical License

The contractors of Electrical Category shall have to produce valid 'A Class' electrical license from the competent authority in the name of the contractor for High Tension and Low Tension lines. They shall keep valid license throughout the period of empanelment by getting it renewed at suitable intervals and submit an attested copy of the same to the empanelment authority after each renewal. In event of any discontinuity in validity of electrical license of the contractor, its empanelment and authority to work with BRIDCUL will also automatically cease to be valid. For applying for tenders for a work in any state they shall have to possess electrical license of appropriate voltage issued by any State Govt. under Clause 45 of compilation of rule of Indian Electricity Rules 1956 or as amended from time to time.

13. Change in Constitution of Firm

The contractor/firm shall not modify the existing partnership or enter into any fresh partnership after empanelment without the prior approval of the empanelment authority. Such proposal, if any, shall be submitted in advance giving full details of the intended partnership/sole proprietorship along with the draft partnership deed/affidavit and documents as per Annexure-VI. Any change in status of the contractor or in constitution of the firm without prior approval of the empanelment authority will render the contractor/firm liable to be removed from the approved list of contractors.

13.1 If a firm is converted in two or more firms by any action of its partners, the new firm(s) or any separated partner(s) in his (their) individual/joint capacity shall have to apply for the empanelment afresh on the basis of work experience gained as a separate entity.

13.2 If new partners are taken in the firm, each new partner shall have to satisfy the eligibility conditions mentioned in Rule 3.

13.3 If the number of original partners of a firm reduces to less than half due to any reason including death of partner(s) the empanelment of the firm shall be withdrawn. Original partners means constituents at the time of empanelment and those who have remained as constituent for more than 5 years.

14. Change in Address

14.1 While applying the empanelment, the contractor should mention address of his Empanelled Office as well as Head Office, if different. All documents i.e. Bankers' Certificate, Electrical license etc. should bear one of the above addresses, otherwise the same shall not be accepted.

14.2 The contractor shall intimate the change, if any, in any of the above addresses, in advance or maximum within one month of such change along with acknowledgement of noting down of such change in address from the Bank, Income Tax, Sales Tax authorities etc. Failure to do so may result in removal of his name from the approved list of contractors.

15. Review of Approved List of Contractors

The contractor shall be required to secure works of appropriate magnitude in BRIDCUL during the empanelment period. Contractors shall be liable to be weeded out for non-observance of empanelment rules. For this purpose the empanelment authority shall have the power to periodically review the approved list of contractors.

16. Revalidation of Empanelment

The validity of initial empanelment of the contractor shall be as given in para 6. It shall be validated on merits after 3 years as per BRIDCUL rules in vogue at that time. Empanelled contractors are requested to submit their application for renewal of empanelment before 90 days of expiration.

17. Contractor's Obligations

The Contractor should fulfill all his obligations under these rules in time and manner as specified, failing which he shall be liable for the action as mentioned therein. Some of the obligations are summarized below:

- (a) Prior approval shall be obtained from the empanelling authority before changing the constitution of the firm/ company.
- (b) Intimation of change of address should be given in advance or within one month along with acknowledgement from Banker, GST and Income Tax authorities.
- (c) He shall continue to possess, throughout the period of empanelment, a valid electrical license of appropriate voltage issued by appropriate authority.
- (d) He should secure works of specified magnitude during the period of empanelment.
- (e) He shall abide by these rules.
- (f) He should not indulge in unethical practices and maintain good conduct.
- (g) He shall execute the works awarded to him strictly as per the terms and conditions of the contract and specifications.

18. Disciplinary Actions

The contractor shall have to abide by all the terms and conditions of empanelment and also by the terms and conditions of the contract and the Notice Inviting Tenders. He shall have to execute the works as per contract on time and with good quality. The empanelling authority shall have the right to demote a contractor to a lower class, suspend business with him for any period, debar him or remove his name from the approved list of contractors indefinitely or for a period as decided by empanelling authority after issue of show cause notice. Decision of the department shall be final and binding on the contractor. The following actions of the contractor shall, in general, make him liable to disciplinary actions:

18.1 Demotion to a lower class

The contractor shall be liable to demotion to a lower class, by the empanelling authority, if he:

- (a) fails to execute a contract or executes it unsatisfactorily or is proved to be responsible for constructional defects; or
- (b) no longer has adequate equipment, technical personnel or financial resources; or

- (c) is litigious by nature; or
- (d) violates any important condition of contract; or
- (e) his staff misconducts or misbehaves with BRIDCUL officials or.
- (f) is responsible for a conduct which may justify his demotion to a lower class or
- (g) any other reason which in view of empanelment authority is adequate for his demotion to a lower class.

18.2 Suspension of business

The empanelment authority may suspend business with a contractor for indefinite period or for a period as decided by empanelment authority, pending full enquiry into the allegations, if the empanelment authority is prima facie of the view that the contractor is guilty of an offence in relation to business dealings which, when established would result in his removal/banning business and it is not considered desirable to entrust new works or continue business with the contractor. Business may also be suspended with a contractor up to a period of one year in case he fails to start the work after the award on two occasions.

18.3 Removal from the approved list

The name of the contractor may be removed from the approved list of contractors, by the empanelling authority, if he:

- a) has, on more than one occasion, failed to execute a contract or has executed it unsatisfactorily; or
- b) is proved to be responsible for constructional defects in two or more works; or
- c) persistently violates any important conditions of the contract; or
- d) fails to abide by the conditions of empanelment; or
- e) is found to have given false particulars at the time of empanelment; or
- f) has indulged in any type of forgery or falsification of records; or
- g) changes constitution of the firm without prior approval of the empanelment authority; or
- h) changes permanent address/business address without intimation to the empanelment authority; or
- i) is declared or is in the process of being declared bankrupt, insolvent, wound up, dissolved or partitioned; or
- j) persistently violates the labour regulations and rules; or
- k) is involved in complaints of serious nature received from other departments which prima facie appear to be true; or
- l) defaults in settlement of tax dues like income tax, Contract tax, GST, octroi duties etc.
- m) has already been demoted for other reason(s); or
- n) Ceases to fulfill eligibility criteria based on which empanelment was done; or
- o) is considered not required to be in list of BRIDCUL for any other reason considered fit by empanelment authority; or
- p) Does not start the work after the same is awarded to him on three occasions.

19. Revision of the Rules

MD, BRIDCUL may modify, add, delete and/or change any of the above rules and same shall be binding on all empanelled contractors.

20. Definition of building work

Items of pre fabricated huts, false ceiling, compound walls, storm water drains, sewer lines, water supply lines, Road – Gully chamber and supply of SFRC covers if executed exclusively under separate contract and not as part of main building contract shall be excluded from the

definition of building work Further for the purpose of empanelment of class I & II contractors of all categories i.e. Civil and Electrical, only the original works, including the works of additions and alterations/renovation will come under the purview of the work as mentioned in the Table I of the Rules.

21. Arbitration & Reconciliation

All disputes will be subject to jurisdiction of Dehradun Court only.

22. Digital Signature Certificate (DSC)

In order to participate in e-tendering method of bidding, contractors are advised to procure their Digital Signature Certificates.
