महोदय,


उपरोक्त विषयक निगम प्रबन्धन द्वारा निगम में निर्माण कार्य हेतु पंजीकृत ठेकेदारों व प्रस्तावित पंजीकरण के सापेक्ष शुल्क व श्रेणी आदि Appendix-A के अनुरूप प्रस्तावित की कर दी गई है, उक्त Appendix-A में USIDCL के स्थान पर BRIDCUL पड़ा जाए।

उक्त के दृष्टिगत निगम में पूर्व से पंजीकृत ठेकेदारों व जिन ठेकेदारों द्वारा पंजीकरण हेतु आवेदन किया गया है व भविष्य में निर्माण कार्य हेतु पंजीकरण के सापेक्ष आवेदन किया जाना प्रस्तावित है उनके द्वारा भी उक्तानुरूप शुल्क दिया जाना प्रस्तावित होगा व उक्त के अतिरिक्त अन्य निर्देश निम्नानुसार है-

1. जो ठेकेदार जिस श्रेणी में सूचीबद्ध है वह उसी श्रेणी की निविदा में प्रतिभाग ले सकता है।
2. ठेकेदारों द्वारा जमा कराई गई सुरक्षा धनराशि को ठेकेदारों की सहमति से पंजीकरण शुल्क में परिवर्तित किया जा सकता है, (रु० 2 लाख/- रु० 1 लाख/- रु० 50,000/- तीनों श्रेणियों हेतु) जोकि वापस नहीं की जाएगी। नये आवेदकों को निर्धारित राशि पंजीकरण शुल्क के रूप में आवेदन के साथ जमा करनी होगी। तत्पश्चात् ही उस पर कार्यवाही की जाएगी। जिन पंजीकृत ठेकेदारों द्वारा उक्त पर पत्र प्रेषण के 15 दिवसों के भीतर अपनी सहमति प्रदान नहीं की जाती है तो उनका पंजीकरण स्वतः ही निरस्त माना जायेगा।
3. पंजीकरण 5 वर्ष हेतु वैध होगा तथा Appendix-A का पंजीकरण हेतु अक्षरक्ष पालन किया जाएगा।


उपरोक्त निर्देश तत्काल प्रभाव से प्रभावी होंगे।

Appendix-A

USIDCL Rules For Registration Of Contractors-2010

The Rules for registration of contractors in the Corporation will be as follows-

- Rule 1)** i) These rules shall be called USIDCL rules for registration of Contractors-2010.
ii) These rules shall come into effect from the date of approval by the Board of Directors.

Rule 2) Contractors will be registered in the following categories.

Category	Eligibility to compete for works costing	Registration Fee
1	More than Rs. 5 Crores < Rs. 10 Crores	Rs. 2,00,000/-
2	More than Rs. 2 Crores upto Rs. 5 Crores	Rs. 1,00,000/-
3	Below 2 Crores	Rs. 50,000/-

- Rule 3** a) The registration shall be valid for 5 years. Up gradation from lower category to higher category shall be permissible by paying the additional fee. In such a case registration in lower category shall stand cancelled.
b) M.D. shall be the registering authority for all categories.
c) All registered contractors shall be eligible for taking up various USIDCL projects any where in the State.

Rule 4 The following documents shall be produced for registration-

- Application in prescribed proforma.
- PAN Card certified Xerox copy.
- Address proof.
- Registration fee in the form of Bank draft in favour of USIDCL payable at Dehradun.
- Partnership deed or certificate of registration as a Limited Company issued by ROC, showing Names of Share holders and copy of Bye-laws or memorandum of articles of Association.

Rule 5 Renewal

- Every 5 years or payment of fees given in Rule-2 above.
- Application for renewal shall be submitted 2 months before the expiry of existing registration.
- Applications for renewal can be submitted latest up to 1 month after the expiry of validity of existing registration.

Rule 6 Application On submission of application in the proforma given in Appendix-1. USIDCL shall issue the registration certificate in Appendix-2.

Rule 7 Black listing and suspension of registration:

- The contractor/proprietorship firms or public/ private limited company registered in any category or his/their authorized representative/s shall be black listed or their registration can be suspended for a specified time period in case they are found guilty of.
 - indiscipline or unbecoming behaviour with any of the officers or employees of USIDCL

- ii) failure to complete the works as per the specifications agreed to in the contract
- iii) creating legal hassles in the Corporation for receipt, presentation or any activity connected therewith for the documents concerning the contracts
- iv) subletting of works to other agencies or persons without the written permission from USIDCL
- v) any attempt to pressurize or inflict physical assault on the staff of the Corporation
- vi) any attempt to sell in the open market any of the materials supplied by the corporation for its works
- vii) presentation of forged or false documents for registration or up gradation etc.
- viii) Not completing the agreement formalities in time after acceptance of tender
- ix) Conviction in any criminal/civil legal proceedings by any court in India
- x) Formation of cartel or group for grabbing the works or deliberate boycott of any tenders invited by the Corporation
- a) It shall be essential to issue a show-cause notice to the registered contractor/ firm/ company before blacklisting or suspension
- b) Orders of blacklisting or suspension shall be passed by the competent officer or his subordinate under whom the contractor has been registered
- c) Appeal against the action taken by the competent authority could be filed before the Managing Director within a period of 30 days from the date of such order/decision

Rule 8

In case of change in the constitution of the registered entity, fresh registration shall be necessary.

Rule 9

In case of change in the Power of Attorney as per the original registration, approval of the USIDCL shall be necessary before the change is accepted and recorded in the records.

Rule-10

The registered entity shall be responsible for promptly informing any change in address to the registering authority.

Rule 11

Time limits for construction, EMD, SECURITY DEPOSIT etc. shall be as follows and the registered entity shall agree to these time limits

1	Up to 100	9 months	2%	5%	Bank Guarantee/DD/FDR from any b schedule banks in India

4	More than 600	24 months	0.75%	2% 1.5%	As above
