## **1. Background**

- 1.1 Nagar Nigam of Dehradun, Uttarakhand has authorized USIDCL to develop the space in front of its office complex.
- 1.2 The proposed market/commercial complex at Gandhi Road/Kutchery Road near Nagar Nigam Dehradun to be develop the existing structure OR the proposed market/commercial complex to be develop afresh after demolishing of existing complex.
- 1.3 Above mentioned proposals at point no. 1.2, the proposal must complying to the bylaws of Mussooree Dehradun Development (MDDA).
- 1.4 In continuation of the same vision, development of a property (commercial) on PPP/License basis has been conceptualized.
- 1.5 In order to finalize the concept and other requirements to undertake property development, USIDCL invites Applicants (“Interested parties” or “Bidders”) to submit their EoIs. Based on the responses of EoIs received, USIDCL shall finalize and initiate the procedure in coordination with Nagar Nigam Authorities.
- 1.6 The issue of this EoI does not imply that USIDCL is bound to undertake the bidding process and select the Applicant.
- 1.7 The bidder shall be called to make powerpoint/video presentation on the concept plan.
- 1.8 The bidder shall prepare the project concept as per the provisions of “MDDA” and applicable building bylaws.
- 1.9 Details of Land parcel is: Area 3,300 sqm (approx).

## **2. Eligibility of Bidders**

Must be a registered partnership firm/LLP/Public Limited Company/Private Limited Company/Individual.

## **3. Technical Qualification**

To be eligible for qualification and short-listing, the bidders shall have to satisfy the following conditions of eligibility.

**(a) Technical Capacity:**

For demonstrating technical capacity and experience (the “Technical Capacity”), the applicant shall have, over the last 10 (ten) financial years preceding the bid due date completed at least one commercial/retail project as a Developer of at least 5,000 sqm built up area.

**(b) Financial Capacity:**

- i. Average Annual Turnover: Average Annual Turnover of at least Rs. 15 Crore (Rupees Fifteen Crore Only) and for the past 3 financial years (2013-14 and 2014-15, 2015-16) in Core Sector
- ii. Minimum Tangible Net worth: At least Rs. 10 Crore (Ten Crore Only) at the end of FY 2015-16.

**Note: Core Sector would be deemed to include Real Estate and Industrial parks/estates.**

**4. Selection Process**

- i. The EoI is issued only with a purpose of collection of information from interested parties and USIDCL reserves the right to proceed ahead with the Project on PPP/License basis. However, the applicants received shall be reviewed carefully and interactions with the applicants are likely to take place before finalization of Project terms and conditions.
- ii. A meeting shall be called for the qualified bidders on 10.02.2017 at 11:00 am at USIDCL office to present the concept plan. Any change in the mentioned date and time shall be communicated to the bidders vide email or through USIDCL’s website.

**5. Application Registration and Instructions**

- i. Applicants are advised to study all instructions, forms, terms, requirements and other information in the EoI carefully.
- ii. Applicant shall be deemed to have applied after careful study and examination of the EoI Document with full understanding of its implications.
- iii. The response to this EoI should be full and complete in all respects. Failure to furnish all information required by the EoI or submission of a proposal not substantially responsive to the EoI in every respect will be at the Applicants risk and may result in rejection of its eligibility.

- ii. The application should be submitted in the Hard Copy in a sealed envelope within the deadline as specified in point no. 8.

- iv. Applicant should submit all formats and suggested documentary evidence with EoI Documents.
