  - Relaxation in terms of upper age limit is admissible to SC/ST/OBC candidates as per the policy of the Uttarakhand Government and for Ex. Serviceman as per GOI rules.
- Candidates serving Govt./Semi Govt./Public Sector Undertaking will be required to submit their application through proper channel along with:-
  - No Objection Certificate from the parent department of the candidate.**
  - Certificate from department that no disciplinary enquiry is going on or pending against the candidate to be submitted.**
  - Copy of Last five years' ACR.**
  - Salary certificate of last drawn salary indicating the level of pay scale (if salary is on IDA, then submit a certificate that the level of IDA is equivalent with CDA).**
- It is required to submit the self attested copies of Educational Qualification, Experience Certificate, NOC and other documents.
- An advance copy of application can be submitted to avoid delay in submission of application through proper channel.
- Allowances and pay protection to candidates on deputation shall be given as per prevailing rules and regulations of the State Government.
